1. Minutes of previous meeting and matters arising not on the agenda:

These were approved.

2. Report from Marketing meeting:

All listed in Joss's briefing note re Bristol Arts District were agreed: to be re-visited and discussed fully in the New Year.

3. Cleansing:

It was agreed that we need improved documentation from Bristol Waste to enable a full review. Sarah Morrison suggested she will set up a 3 way zoom between herself, Joss and Bristol Waste.

4. East Street Now!

Joss is facilitating these: the next meeting will be on Wednesday 4 january 2023, location tbc and agenda to follow.

5. BID projects:

-EAT Festival: April signed off. September date clashes with Windmill Hill City Farm market: a discussion will be organised re running a joint promotion.

-East Street Market: this will be piloted on the last Saturday of each month from April to September 2023. The organisers are to be invited to a BID meeting.

-12 Drinks of Christmas has gone live: feedback needed from venues so that it can be properly evaluated.

-North St/West Street tree lighting: Sparkx gesture of goodwill to install 2 of the 6 old trees was acknowledged, plus the offer to install on the remaining 4 at a heavily reduced price of £2.5K. It was agreed to ask whether they would include an extra tree on West Street for a complete price of £3K: Joss to action.

Tom Windaybank proposed that the tree lighting should remain until January. This was seconded by Darren Baker, with a positive vote from 6 directors and 1 abstention.

6. AOB:

-British BID membership is being processed with training opportunities for Board members. It was agreed that we would offer 50% off the cost of a course to the new BID Manager during the recruitment process.

-It was noted that Joss is investigating a replacement hanging basket scheme.

-Joss is creating a framework for project evaluation and clear delivery reporting.

-Stef and Joss are to undertake a governance review in the New Year, which will include recommendations of the roles and appointment of directors.

-Stef and Andrew Procter had produced documents on Financial and Procurement processes which will be accessible within key documents on the website.

BBID: DEC OPEN MEETING MINUTES

-Stef has arranged to work with Joss on an insurance and Health & Safety review in the New Year.

-Steve Clymer suggested that a strategy review is required, and it was agreed that the current business plan would be circulated with these minutes, and that the business plan will be re-developed with the new BID Manager as part of the ballot process during 2023.

DIGITAL 2018 - 2023 BBID BUSINESS PLAN

- Shadene introduced herself and described her aim to develop a Community Hub on East Street. Stef pointed out that there is a consortium of Bedminster community groups (Action Greater Bedminster, BS3 Community Development and Windmill Hill City Farm working with the City Council to establish a community hub in a vacant shop. She understands that the Regeneration team at the "City Council has committed a small start up rund, and she had spoken to Simon about the BID securing a presence within the Hub. She will put Shadene in touch with the community contacts. The BID Chair, Simon Dicken, thanked everybody for their work over the past few weeks. He believes we are in a strong position to go forward. He stated that some people had said that George Grace has been treated unfairly, but he assured the group that due process had been followed. Skill sets required have changed and we need to move on. However, the 10 years that George has given to the BID does need acknowledgement. Everyone agreed.

- New BID Manager would be under a short term contract either way
- BM will need support. Who will this be?
- Allow additional time for new BM to get to know the traders and make an impact/relationship build

 - B. Keep in situ and turn on summer + winter
 - C. Remove and reinstall

VOTE NEEDED

ART DISTRICT:

- Branding is underway
- Fluid design approach allowing the design to have more longevity and lasting power beyond the BBID
- Propose a branding workshop, trader engagement and review with BID Board (SH)
- Additional amplification proposal. Plaster/Joss
- Looking at a weekend date for launch event and what this might look like. Plaster/Joss
- Potentially funded R&R
